He sent me all the paperwork he filed for a disposal order on two dogs owned by Erasmo Farinas and Maria Farinas of Wilton. The dogs our not licensed, not up to date on rabies, have been a nuisance, and on two separate occasions have bit and hospitalized people. The first occasion was on 4/23/24, where the dogs Betsy and Marge bit a woman taking a stroll on a public roadway. This woman was transported to Norwalk hospital with multiple bites. The keeper was issued an infraction for 2 counts of nuisance dog. The second incident happened on 11/23/24, where the same two dogs bit a man teaching his son to rollerblade at a school. This man was transported to Norwalk hospital with multiple bites and received rabies treatment as the dogs were not up to date with their rabies vaccine. ACO Muir informed me that the family owns a boarding kennel in town called Bone & Bark Inn 15 Cannon Rd. Wilton, CT. 06897
